**FINAL RELEASE AND INDEMNIFICATION AGREEMENT FOR PARTICIPATION IN**

**1. CONSENT FOR PARTICIPATION**

In consideration of my participation in the Activities, I hereby for myself, my heirs, executors, administrators and assigns (herein collectively referred to as the "Releasers"), forever release, remise and discharge Fuel Creative inc., and the wholly owned and original automotive entertainment event known as Sfida Di Velocità, without limitation, her directors, employees, volunteers, shareholders, officers, servants, agents, employees (herein collectively referred to as the "Releasees"), jointly and severally from any and all actions, causes of actions, contracts (whether express or implied), claims and demands for damages, losses or injury, suits, debts, sums of money, indemnity, expenses, interest, costs and claims of any and every kind and nature whatsoever, at law or in equity, which against the Releasees and Releasers ever had, now have or can hereafter have and arising out of my participation in the Activities (collectively "Liabilities"), except in the case where such Liabilities are attributable to the negligence of any of the Releasees.

**4. INDEMNIFICATION**
